2, 2010 speech. The retired professor of Miami-Dade College taught the members of the society many tricks he learned years ago when working as an apprentice with Bob Wilson — an informal educator who provided McAlpin with many of the tricks shown at the lecture.

The brief outline of the 10 rules are:(1) keep the water in the tanks of the plants; (2) use well drained soil mix; (3) uniform water moisture program; (4) use an appropriate pot for the plant; (5) put the pot in the

appropriate location; (6) remove pups at the proper time; (7) fertilize at the proper time(s); (8) control insects and diseases; (9) secrets of seed germination; and (10) protect plant from heat and cold.

into the accuracy of that statement, I could only respond that if that were true... But, the fact that such discussions is more problematic than whether the same is or is not true.

Placing the burden of the evils associated with Zika upon the narrow shoulders of the plant world is most misleading. Manmade products account for many more convenient breeding grounds, yet they manages to lay blindly blameless. After all, who could survive without plastics?

The plant, unlike manmade objects, only delivers oxygen tot he air, reduces carbons, and delivers colors to the landscape. Petroleum based plastics aggravate what plants counter. Yet, people abhor the plants, and leave nothing in the conversation for manmade products. Equally bold are the proclamations that global warming is a hoax, or that climate change in not generated from



human behavior. No. blame the natural world which existed for eons without problems until a Big Bang rocked the lands and waters. which precipitated h evolutionary

development of species, to land dwellers, to knuckle draggers, to two footer, to . . . us.

And, man is attempting to counteract Zika, but as one specialist doctor told the presss only a week or two ago – "We can't protect women and children." Dr. Tom Frieden finished that lamentful comment with "It will take years to develop a vaccine." Doom and gloom is upon

But, most importantly, the man, who is in charge of the group which coalesces to deliver an army to d e f e a t t h e "unprecedented" viral

birth defect known as

Zika's microcephaly, effectively is telling everyone that even drastic measures such as spewing Agent Orange upon all of the gardens in Southern Florida would *not* stop Zika.

Until there is vaccination, there is only man made prevention. "So, one of the most effective control measures for mosquitoes is draining all sources of standing water around your home or business at least weekly," Department of Health spokeswoman Mara Gambineri said. "This includes garbage cans, house gutters, pool covers, flower pots, toys and anywhere rain or sparkler water has collected." Interesting, all of those listed items are *not* plants. The list is devoid of mention of bromeliads.

Better yet, do something to make the mosquitoes lives miserable. "If you must be outside when mosquitoes are active, cover up your skin by wearing long pants, long sleeves, shoes and socks," Gambineri said. "Residents



should also apply m o s q u i t o repellent to bare s k i n a n d clothing." The state recommends repellents with DEET, picaridin, oil of lemon

eucalyptus and IR3535, or others.

#### AMENDMENT TO THE BY LAWS

Pursuant Article VIII of the Bylaws, the following provisions are set for amendment.

Items in red are the amendments to Articles III and VII.

#### ARTICLE III. OFFICERS AND THEIR DUTIES

SECTION 1. The business of the society shall be conducted by a Board of Trustees, hereinafter referred to as the Board, subject to the directives and restrictions contained in these bylaws. The Board shall be composed of the officers and four directors elected by the active members of the Society.

SECTION 2. The officers of the Society shall be a President, Vice President, Secretary and Editor. Except for the Treasurer and Editor, they shall be elected for one-year terms and shall serve until their successors take office. The positions of Treasurer or Editor can be renewed on a yearly basis upon approval of the Board. The President, Vice President and Secretary shall not serve in the same office for more than two consecutive terms.

SECTION 3. The President shall preside at all meetings of the Society and Board and shall be a member ex officio of all committees except the nominating committee. With the concurrence of the Board, the President shall also appoint such committees as are deemed necessary except for the nominating committee, the composition of which is designated in Article VII, Section 1.

SECTION 4. The Vice President shall perform all duties of the President in the absence of the President and shall be responsible for programs.

SECTION 5. The Secretary shall keep a record of all meetings of the Society and the Board and shall undertake such correspondence as the President or Board shall authorize. The Secretary shall serve as clerk at all elections.

SECTION 6. The Treasurer shall be custodian of all financial records and monies of the Society. The Treasurer shall disburse funds as directed by the Board and shall receive all dues.

SECTION 7. The Directors shall be elected for terms of two years and may not serve more than two consecutive terms. SECTION 8. The Board is empowered to fill all vacancies in its composition between annual elections.

SECTION 9. The Board is empowered to authorize expenditures of not more than \$250.00. Expenditures over this amount must be authorized by a majority vote of members present at any regular or special meeting of the membership. The \$250.00 limitation does not apply to expenditures, which will be reimbursed, or to reasonable amounts necessary to provide programs.

SECTION 10. Should any person hold more than one of the titles listed in SECTION 2, that person will b entitled to only one vote.

#### ARTICLE VII. NOMINATIONS AND ELECTIONS

SECTION 1. The nominating committee shall consist of three members of the Society. The Chairman shall be elected from the Board at the August Board meeting and the other members shall be elected by the Society at its regular meeting in September.

The nominating committee shall report at the October meeting at which time nominations may be made from the floor providing the consent of the nominee has been obtained. Nominations from the floor may also be made at the November meeting with the same stipulation regarding consent of the nominee.

SECTION 2. A majority vote of the members present at the Annual Meeting shall constitute a valid election. When more than one nominee is presented for an office, the voting shall be by secret ballot and tallied by the Election Clerk. Section 3. No member shall serve in the same office for more than two consecutive terms. Members who have held office for more than one-half the normal term shall be deemed to have held that office for a full term.

SECTION 4.Notwithstanding the provision of this Article VII, section 3, the Treasurer's <u>or Editor's</u> position may be renewed on a yearly basis upon approval by the Board.
